4.	<ul> <li>THREE OAKS RENEWABLE ENERGY PARK EXTENSION Richard Barker and Daniela Jenkins introduced themselves to all present and then addressed questions previously put forward by Parish Councillors. Responses and information included the following: <ul> <li>One of the proposed turbines is to be sited within the designated area of the solar farm and therefore an amendment to the solar farm application will be submitted. Since the original application, more powerful panels are available, therefore the number of panels can be reduced to accommodate the wind turbine.</li> <li>Newsletters will be distributed once the planning application has been submitted and validated.</li> <li>The Community Benefit Fund remains under negotiation, and Ridge Clean Energy continues to welcome proposals aimed at achieving a solution that meets the aspirations of all parties.</li> <li>Improvements to the green lane track leading to the site will be included within the planning application and reviewed by civil engineers to ensure accessibility and address potential flooding concerns.</li> <li>Biodiversity Net Gain will form part of the planning application and will include an environmental assessment. Ridge Clean Energy hope to exceed the 10% minimum BNG increase required under planning</li> </ul></li></ul>
